

Codicil Form

A Codicil is a simple legal document which allows you to make changes to your existing will, such as to add a gift to Orchid without you needing to write a new will.

A template Codicil form is shown overleaf.

As a Codicil is a legal document, **if you wish to make a Codicil to change your will to add a gift to Orchid we would recommend you seek legal advice from a solicitor before completing this form**. A solicitor will be able to further advise you as to how this Codicil form will impact your existing will in relation to your own particular circumstances and how to execute the Codicil properly to ensure it is completed legally and correctly.
